## New Hospital Programme – moving forward

The government has reconfirmed its commitment to deliver 30 new hospitals by 2030 under the New Hospital Programme (NHP). We are delighted for our clients who are part of the programme and have been waiting for this announcement. Individual financial envelopes are to be confirmed shortly and this promises to be biggest investment in NHS infrastructure in a generation.

Importantly, the government has also confirmed that the programme will include the complete rebuild of the hospitals with reinforced autoclaved aerated concrete (RAAC), with a commitment to fully fund and deliver these new hospitals by 2030. This was expected and vital to deal with the ongoing risks each of these Trusts are having to deal with as a result of the potential structural instability resulting from the use of RAAC.
